

TERMS AND CONDITIONS

The following terms and conditions are applicable to **Win a BYD Sealion 7 Lucky Draw** (“Lucky Draw”) organised by SG International Marathon Pte Ltd (“SGIMPL” or the “Organiser”):

1. The Organiser is SG International Marathon Pte Ltd (“Organiser”)
2. The Sponsor is BYD (“Sponsor”)
3. The Contest is known as Win a BYD Sealion 7 Lucky Draw (“Lucky Draw”)
4. The winner is 1 drawn registered individual who has participated in the BYD Singapore International Marathon presented by adidas and whose ticket ID has been selected by the Organiser (“Winner”)
5. The BYD Sealion 7 is known as the Prize (“Prize”)
6. The Sponsor agrees to provide **one (1)** Prize for the Lucky Draw, to **one (1)** Winner, subject to the fulfilment of the terms in this Agreement and its Schedule.
7. The Sponsor acknowledges that the Lucky Draw is organised and administered by the Organiser, and that the Sponsor’s role is limited to the Prize sponsorship only.

Prize Scope and Exclusions

8. The Sponsor shall provide the Prize strictly as described in **Schedule 1**, and acknowledges that the Prize is limited to the motor vehicle specified therein. For clarity, the Prize comprises the vehicle only and **does not include** any ancillary or consequential costs associated with vehicle ownership, operation or registration. Without limitation, the Prize expressly excludes, and the winner of the Prize shall be responsible for procuring and paying for the following:
 - i. Certificate of Entitlement (“COE”);
 - ii. motor vehicle insurance;
 - iii. road tax;
 - iv. Vehicle Emissions Scheme (VES) surcharge, if applicable;
 - v. servicing program;
 - vi. On-Board Unit installation;
 - vii. number plate;
 - viii. Goods and Services Tax (GST);
 - ix. registration fee;
 - x. Additional Registration Fee (ARF);
 - xi. any fittings, fixtures, and accessories other than those provided by the Sponsor in its sole discretion;
 - xii. other incidentals, etc.; and
 - xiii. any other fees, charges or costs not expressly stated in Schedule 1 to be included as part of the Prize.
9. The winner shall pay the cost of the goods and services tax, road tax, motor vehicle insurance, Additional Registration Fee (ARF), Vehicle Emissions Scheme (VES) surcharge (if applicable), registration fees, Certificate Of Entitlement (COE), number plate and On-Board Unit installation of the Prize and register the Prize within 1 month from the date of announcement of the result of the Promotion (failing which all charges for warehousing or any other payments due on the Prize must be paid by the winner for the period exceeding 1 month until the Prize is registered and all relevant fees, costs and expenses are paid). All payments arising from or in connection with the Prize shall be made in full before collection of the Prize.

10. The Sponsor may (but is not obliged to) assist in obtaining COE on behalf of the winner subject to the following:
 - i. The winner may either request the Sponsor to bid for the COE on his or her behalf or obtain the relevant category's COE by his or her own means;
 - ii. Any request from the winner for the Sponsor to bid for the Prize's COE on the behalf of the winner shall be according to the Sponsor's prevailing terms and conditions for providing such service, including but not limited to the payment of the COE bidding deposit of SGD10,000 (or such amount as may be applicable at the relevant time), including applicable GST, by the winner at the time of request; and
11. The colour of the Prize is determined by the Sponsor at its sole discretion. The fittings, fixtures and accessories of the Prize shall also be determined by the Sponsor at its sole discretion.

Prize Fulfilment and Redemption

12. For verification purposes, the winner shall be required to present in person the original notification letter from the Organiser and his or her physical NRIC / FIN to the Sponsor on the scheduled appointment date and location as determined by the Sponsor when claiming the Prize.
13. The Organiser shall be solely responsible for all aspects of prize fulfilment and redemption. Without limitation, this shall include the following obligations:
 - i. Verifying the identity of the winner and confirming eligibility in accordance with the applicable Lucky Draw terms and conditions;
 - ii. Clearly explaining to the winner the Prize redemption procedures, timelines, and any documentation or information required to complete redemption;
 - iii. Link up the Winner and the Sponsor for the registration, preparation and physical handover of the vehicle to the Winner in compliance with all applicable laws and regulatory requirements in Singapore.
14. The Sponsor shall use commercially reasonable efforts to complete the prize fulfilment and handover to the Winner within a reasonable timeframe after initial contact, taking into account the Prize's availability and regulatory processing timelines, and subject to the Winner's completion of required documentation and payment of all costs set out in paragraph 3.
15. The Sponsor shall not impose any additional terms, conditions, restrictions or requirements on prize redemption other than those detailed in this agreement, unless:
 - a) expressly approved in writing by the Winner, Sponsor and Organiser; and
 - b) is consistent with the Lucky Draw T&Cs published by the Organiser.
16. For the avoidance of doubt, the Sponsor shall not condition prize redemption on the Winner making additional purchases, entering into unrelated agreements, or agreeing to marketing arrangements beyond those expressly agreed in writing or permitted under the Lucky Draw T&Cs.
17. After collection of the Prize, the Organiser shall be responsible for responding to and communicating with the winner directly with respect to all issues relating to the Lucky Draw,

while the Sponsor shall be responsible for responding to and communicating with the winner directly with respect to all issues relating to the Prize.

18. In the event that the Winner decides to forfeit the Prize in exchange for cash, the cash value of the Prize is at XXX Singapore Dollars. There is no negotiation of the cash value sum, and the Organiser reserves its rights to disqualify the Winner should there be any dispute. The Organiser shall then draw for another Winner.
19. The Organiser also reserves the rights to offer the Winner the Cash value of the Prize at xxx Singapore Dollars, should the Winner be found to not satisfy the requirements of the Organiser and the Lucky Draw.

Personal Data and Lead Sharing

20. By participating in the Promotion and/or claiming the Prize, the participants give consent to the Organiser and the Sponsor and their respective related corporations, business partners and agents to collect, use and disclose their name and other personal data ("Personal Data"), including but not limited to, personal identification information, contact details, image and voice for identification purposes in connection with the Lucky Draw, and registration and delivery of the Prize to the winner. The winner additionally agrees to the collection, use and disclosure of his or her Personal Data by the Organiser and the Sponsor or their related corporations, business partners and agents in newspapers, radio, social media and other medium as may be determined by the Organiser and/or the Sponsor, and to be photographed, filmed and/or interviewed and to co-operate with and participate in the activities organized by the Organiser and/or the Sponsor or its related corporations for publicity, sales and marketing and promotional purposes without any compensation.
21. The Organiser acknowledges that the usage of the Winner's Personal Data to the Organiser and/or the Sponsor is **only** strictly in accordance with applicable data protection laws.
22. The Organiser and/or the Sponsor shall:
 - a) use such Personal Data solely for the purposes consented to by the relevant data subjects;
 - b) comply at all times with applicable data protection laws and the Agreement; and
 - c) implement appropriate technical and organisational measures to protect such Personal Data.
23. The Organiser and/or the Sponsor shall not disclose, sell or otherwise transfer any Personal Data received from the Lucky Draw to any third party without any prior written consent and the consent of the relevant data subjects, except as permitted under this agreement.
